III. Special Topic

Measurement beyond GDP - the Use of Surveys

Surveys among economic agents provide insights into their behaviour and motivations and thereby enrich economic research with new perspectives and research questions, e.g. in the fields of business cycle research, welfare measurement, socio-economic analyses, public choice, behavioural economics, etc. Economic policy currently has begun to challenge traditional measures of public welfare and turns to alternative concepts, which take a broader perspective on welfare and the determinants of economic behaviour (e.g. European Commission's "Beyond GDP"initiative, and the French "Commission on the Measurement of Economic Performance and Social Progress"). Against this background we invite papers which use survey data to contribute to a better understanding of the judgements, perceptions, values, motivations and behaviour of economic agents.
