Registration Note

You are responsible for ensuring you are registered in the correct courses. Prerequisite Note

The prerequisites for this course are Economics 2122A/B; and 0.5 course from: Mathematics 1225A/B, Calculus 1000A/B, Calculus 1500A/B or the former Calculus 1100A/B. You are responsible for ensuring that you have successfully completed all course prerequisites, and that you have not taken an anti-requisite course [in this case, *Economics 2223A/B*]. Lack of prerequisites may not be used as a basis for appeal.

If you are found to be ineligible for a course, you may be removed from it at any time and you will receive no adjustment to your fees. This decision cannot be appealed.

If you find that you do not have the course prerequisites, it is in your best interest to drop the course well before the end of the add/drop period. Your prompt attention to this matter will not only help protect your academic record, but will ensure that spaces become available for students who require the course in question for graduation.

Course Information

Course Objective

The goal of this course is to give students a thorough understanding of the basic tools of econometric analysis using commonly used regression models. The class will study both theoretical foundations and empirical applications of econometric models.

Learning Outcomes

- Students will learn how to formulate, estimate, and test economic models.
- Students will be able to identify what linear regression models reveal about economic relationships and interpret the obtained quantitative results.
- Students will learn and be able to apply appropriate techniques to perform valid statistical inference.

Meetings

The lecture hours are Monday and Wednesday from 7:00 pm to 10:00 pm and will take place in SSC 3028. I will be available in SSC 4107 (rather than my office) for the scheduled office hours and in my office (SSC 4048) by appointment in situations where you have questions but unable to make it to my office hours. I will accommodate appointment requests submitted 48 hours before the requested appointment. I will make an announcement in case any additional office hours will be held prior to the midterm examination or the final examination. When contacting me by e-mail, please, use your UWO e-mail and indicate **ECON 2123** as the subject of the message. I will not answer material-related questions via e-mail. Please, note that while class attendance is not a component of your grade it is essential for the successful completion of the course.

Assignments are due at the beginning of class. Late assignments (submitted later than 7:15 pm) and missed assignments will be awarded the grade of zero. Students will be provided with instructions regarding the required formatting of assignments at the beginning of the course. The midterm test will be administered during class time. There will be a lecture following the midterm. The time and location of the final examination will be provided by the Registrar's Office. I will announce the material covered by the midterm examination and the final examination in class.

Policy on Missed Exams and Quizzes

If you miss the midterm, it is your responsibility to inform the instructor within 48 hours of the exam. Only absences with a valid reason, with proper approved documentation, will be granted accommodation. Otherwise, you will receive a mark of zero. If the midterm is missed, its weight will be transferred to the final examination. Hence, the final examination will have the weight of 75%. No make-up midterms will be provided.

Students are responsible for verifying that the calculators they intend to use during an examination does not have programmable memory functionality. 9. Faculty of Social Science policy states that oversleeping or misreading an exam schedule is not an excuse for a make-up. This rule applies to all mid-term tests and final exams in the Department of Economics.

Policy Regarding Makeup Tests and Final Examinations

Academic Accommodation will **not** be granted automatically on request. You **must** demonstrate by documentation that there are **compelling** medical or compassionate grounds before academic accommodation will be considered.

If you decide to write a test or an examination, you must be prepared to accept the mark you earn. Rewriting tests or examinations, or having the value of the test or examination reweighted on a retroactive basis, is **not** permitted. Book airline flights after you know the dates of your final examinations. Airline flights must not conflict with test or final exams.

If you are requesting a makeup test for a midterm or a final examination, unless medically incapable, notify your instructor by email or phone, preferably prior to the scheduled date of the test, but definitely within <u>24 hours</u> of the date of the test or exam. Failure to follow this procedure may result in denial of a request for academic accommodation or result in a grade of zero. Set up an appointment as soon as possible to meet personally with your instructor. If the instructor is not available, you may send an email message, copying the Undergraduate Coordinator at econugrd@uwo.ca (Social Science Room 4075). Notifying your instructor of a missed test or exam does not automatically entitle you to a makeup test.

Students who seek a makeup test or examination must provide medical or other relevant verification that their absence from a regularly scheduled test or examination is beyond their control. Documentation must support your reasons. Medical documentation should be given to the Academic Counselling Office of your *home* Faculty <u>as soon as possible (preferably within 24 hours of the test)</u> if you know you may not be able to write your final examination on the scheduled day and time.

Failure to follow this procedure, or to provide supporting documentation, may result in denial of a request for academic accommodation or result in a grade of zero. If your documentation is not acceptable, you will be given a zero for the missed test.

For personal illness, if you consult Student Health Services regarding your illness or personal problem, you should request a Student Medical Certificate from the physician. If you were seen by an off-campus doctor, obtain a certificate from his/her office at the time of your visit. The off-campus medical certificate form must be used and can be found at:

For any other circumstances, if you are not sure what documentation to provide, ask your Academic Counsellor. If your documentation is judged sufficient, the academic counselor will issue a Recommendation for a Special Examination (a single form for midterms or a triple color form for final examinations). Once you have this form, contact your instructor ASAP to make arrangements. Even if approved from your home faculty Academic Counsellor, there is no guarantee that you will be allowed to write the makeup test and exam.

For final examinations, you need permission from your *home* Faculty Counsellor, your instructor, and the Department Chair. Failure to follow this procedure may result in an examination grade of zero. You must ensure that the Special Examination form has been signed by the instructor and Department Chair and that the form is returned to the Academic Counseling Office for approval without delay. Make-up final examinations, if permitted, will be written within one month of the end of the exam period.
