### **Course Objectives:**

This course is divided into three parts: i) international trade and ii) international macroeconomics iii) current events

Part (i) deals with trades between countries regarding the patterns, terms, and gains from the trades. To explore these topics, we will cover major trade theories in detail. Current trade policies will be analyzed using these theories with attention to mismatches between theory and policy. Part (ii) deals with the foreign exchange market, its determinants, and policies under different exchange rate regimes. We integrate the knowledge of how the foreign exchange market works with international flow of financial assets in the world economy. Part (iii) will cover current events related to trade such as NAFTA renegotiation, Brexit, China/US tariffs etc to explore the causes of these events and the predicted effect on citizens of a country.

# **Course Learning Outcomes:**

- Students will be able to apply different trade theories to show how different economies can gain from trade
- Students will be able to recognize how immigration and investment policies (mobility of factors) affect different economies
- Students will learn how trade policies affect economies differently depending on the market structure
- Students will learn how the exchange rate is related to prices and interest rates
- Students will learn about different exchange rate regimes and policy implications under each regime
- Students will gain an understanding of how international economics will affect the citizens of a country, particularly Canada

# **Course Learning Outcomes:**

#### **Textbook:**

Suggested Textbook: Essentials of International Economics (3<sup>rd</sup> edition), Feenstra, Robert and Alan Taylor, Worth Publishers 2015.

The course will follow this textbook most closely but any undergraduate level textbook on international economics which covers the topics in the course schedule below should be an acceptable substitute.

#### **Grading:**

The distribution of the marks is as follows:

Two quizzes: 20% (Two in- class quizzes, announced one week in advance)

Midterm: 30% (Time and location will be posted on OWL) Final: 50% (Time and location will be posted on OWL)

There will be no make-up quizzes. If you were unable to attend lectures and missed one or two quizzes, you may provide supporting documentations to adjust the marking distribution.

All quizzes, and exams will be composed of multiple choice and short answer questions.

The final exam covers all course materials, and will take place during the final exam period (June 25 & 26). Exact schedule will be determined by the Registrar's Office

# **Policy Regarding Makeup Tests and Final Examinations**

Academic accommodation will **not** be granted automatically on request. Students **must** demonstrate by documentation that there are **compelling** medical or compassionate grounds before academic accommodation will be considered.

Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or having their value reweighted on a retroactive basis, is **not** permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with test or final exams.

Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within **24 hours** when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. If the instructor is not available, send an email message, copying the Undergraduate Coordinator at <a href="mailto:econugrd@uwo.ca">econugrd@uwo.ca</a>. Notifying instructors of a missed exam does not automatically entitle students to a makeup.

Students who seek a makeup exam must also provide supporting medical or other relevant documentation that their absence from a scheduled test or exam is beyond their control. Documentation should be submitted to the Academic Counselling Office of the student's *home* Faculty **as soon as possible (preferably within 24 hours of the scheduled test)**. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. If the documentation submitted is not acceptable, students will receive a zero for the missed test.

For personal illness, students may consult Student Health Services and request a Student Medical Certificate from the physician. If assessed by an off-campus doctor, students must obtain a certificate from his/her office at the time of the visit. The off-campus medical certificate form must also be used and can be found at:

Notes stating "For Medical Reasons" are not considered sufficient.

For religious or compassionate circumstances, students should ask their Academic Counsellor what documentation to provide. If documentation is judged sufficient, the Academic Counsellor will issue a Recommendation for a Special Examination (a single form for midterms or a triple-color form for final exams). Once students have this form, they must contact their instructor as soon as possible to make arrangements. Even if approved by their Academic Counsellor, there is no guarantee that students will be allowed to write the makeup test/exam.

For final examinations, students need to seek permission from their *home* Faculty Counsellor, Instructor, and the Department Undergraduate Director. Failure to follow this procedure may result in a grade of zero. Students must ensure that the Special Examination form has been signed by the Instructor and Department Undergraduate Director and that the form is returned to the Academic Counselling Office for approval without delay. If approved, makeup examinations will be written within one month of the end of the exam period.
