Course Description:

Teaches students the economic principles that underlie and inform business decisions. Topics include input procurement, product pricing strategies, managing risk, and responding to

changes in legal and regulatory environments. The over-riding goal of the course is to make students better decision-makers in a business or institutional context.

Course Objectives:

Provide students with a high level overview of the issues involved in the management of businesses in Canada

Course Learning Outcomes:

Students will be able to discuss the issues involved in business management and decide if they wish to pursue future studies in this area

Textbook(s) and Course Materials:

No textbook, lecture specific readings will be provided on OWL

Assessments and Grading:

Course evaluations will consist of three midterms and one final exam. All tests will be closed book. All tests will consist of long answer questions.

The final exam will be worth 38% of the course mark.

There will be three midterms. The midterm for which a student receives the lowest score will be dropped, the remaining two will each make up 31% of the course mark. If a student misses a midterm for any reason then this will be the midterm which is dropped. If a student misses more than one midterm then subsequent missed midterms will have their mark weight moved to the final exam.

Policies Regarding Academic Accommodation

- Accommodation for Students with Disabilities: Students with disabilities or accessibility challenges should work with Accessible Education (formerly SSD, see http://academicsupport.uwo.ca/accessible_education/index.html), which provides recommendations for accommodation based on medical documentation or psychological and cognitive testing. - Rewriting Exams and Retroactive Reweighting are NOT Permitted: Students who
 proceed to write a test or examination must be prepared to accept the mark. Rewriting
 tests or examinations, or retroactive reweighting of marks, is not permitted. SelfReported Absences cannot be used once a student has proceeded to start to write a test
 or exam.
- **Self-Reported Absences:** Students will have two opportunities during the fall and winter terms to receive academic consideration if they self-report a missed assessment using the online self-reported absence portal, provided the following conditions are met: the assessment is missed due to an absence of no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted otherwise on the syllabus. Students are not able to use the self-reporting option in the following circumstances:
 - for exams scheduled by the Office of the Registrar (e.g., final exams)
 - absence of a duration greater than 48 hours
 - assessments worth more than 30% of the student's final grade
 - if the student has opened or started the test or exam
 - if a student has already used the self-reporting portal twice during the fall/winter terms

If the conditions for a Self-Reported Absence are *not* met, students will need to provide a Student Medical Certificate (SMC) if the absence is medical or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office for more information about the relevant documentation. It is strongly recommended that students notify the instructor as soon as possible, ideally before the assessment, when they become aware of an absence. University policy is that students must communicate with their instructors no later than 24 hours after the end of the period covered by the SMC or immediately upon their return from their documented absence. Failure to follow University policy and procedures may result in denial of academic accommodation and a grade of zero.

- Documentation for Accommodation: Individual instructors are not permitted to
 receive documentation directly from a student, whether in support of an application for
 consideration on medical grounds or for other reasons. All required documentation
 for absences that are not covered by the Self-Reported Absence Policy must be
 submitted to the Academic Counselling office of a student's Home Faculty.
