Note: Students wishing to enroll in higher-level courses in the Department of Statistics and Actuarial Sciences are encouraged to consult that department.

Note: This course cannot be taken concurrently with or prior to taking Data Science 1000A/B as they will become antirequisites to one another in these sequences.

Course Description:

An introduction to econometric description and inference which covers descriptive statistics for cross-section and time-series samples, probability; probability distributions and random variables; estimators and sampling distributions; confidence intervals and tests of hypotheses; simple linear regression

Course Objectives:

Economics 2122 is an introductory course in statistics with applications in economics and business. Statistics deals with collecting, analyzing, interpreting, and presenting empirical data. Thus, the main objective of this course is to train students in basic statistical techniques including descriptive and inferential statistics. Topics covered include data description, probability theory, sampling distribution, and hypothesis testing.

Course Learning Outcomes:

After successful completion of Economics 2122A, students will be able to:

- 1. Represent economic relationships using graphical and mathematical methods.
- 2. Calculate and interpret probabilities.
- 3. Calculate and interpret probability distributions for discrete and continuous random variables
- 4. Calculate and interpret confidence intervals and understand the process of hypothesis testing.
- 5. Make inferences about populations based on quantitative analysis of sample data.

Quizzes

There will be eight quizzes. Only the top six of the eight will count towards the final grade. Quizzes will be administered through the Mylab online platform associated with the textbook. Quizzes will be 30-40 minutes long, consist of multiple-choice questions, and held during class time at the classroom.

In-class quizzes have flexible grading, meaning that the 2 lowest quiz scores are dropped from the calculation of your grade. For this reason, self-attestation is not accepted for quizzes, in accordance with University policy.

Data assignments

Two data assignments will be administered through OWL's course site. Assignments will involve data analysis, visualization, and statistical testing using R or Excel. Students will have one week to submit the assignments after being posted with a 48-hour grace period for late submissions. Assignments submitted after the late submission period will not be accepted and will receive a mark of zero.

Please note that because the submission deadline for the data assignments already includes flexibility in the form of a 48-hour submission window after the deadline. Due to the flexibility in this assessment, self-attestation is not accepted for late assignments, in accordance with University policy.

Midterms and Final Exam

The midterm and the final exam will be closed book. The midterm will be taken during class at the classroom. The midterm and the final exam will consist of multiple choice, true/false, calculation/graphing, fill-in-the-blank questions, and/or short answer question. The midterm will be 90 minutes long and the final exam 120 minutes long. During exams, students are forbidden to communicate with any person other than an examination proctor or the instructor.

Please note that the midterm exam is considered central to the learning objectives for this course. Accordingly, students seeking academic consideration for this assessment will be required to provide formal supporting documentation as outlined in the *Policy Regarding Academic Accommodation*. To be clear, students cannot self-attest for the midterm exam. Students who are granted academic consideration for this assessment will have the weight of the midterm shifted to the final exam; there are no make-up midterms. Also, note that the University policy precludes students to self-attest for the final exam.

For option 3) note that R must be installed first (https://cran.r-project.org/). RStudio Desktop provides a more friendly programming environment and is used in conjunction with R (https://posit.co/download/rstudio-desktop/).

Policies Regarding Academic Accommodation

- Academic accommodation will not be granted automatically on request.
