Course Description:

Econometrics I introduce essential concepts and techniques in econometrics, emphasizing statistical methods and their applications in economics. The course delves into crucial topics such as descriptive statistics, probability distributions, sampling, estimation, confidence interval and hypothesis testing. The primary goal is to empower students with the necessary tools to analyze data, formulate statistical models, and interpret the outcomes for effective economic decision-making.

Course Objectives:

Econometrics I (EC2122A) aim to give students an introductory understanding of statistical and econometric techniques utilized in the examination of economic data. By the conclusion of the course, students will possess the necessary tools to gather, analyze, and interpret data to inform economic decision-making. The course focuses on both theoretical comprehension and practical application.

Course Learning Outcomes:

After successful completion of EC2122A, students will be able to:

1. Use descriptive statistics and probability theory to analyze and comprehend data trends in economic situations.
2. Calculate and interpret probabilities.
3. Undertake point and interval estimation, as well as carry out hypothesis tests for various economic data scenarios.
4. Develop and estimate simple linear regression model to investigate connections between economic variables, while simultaneously critically evaluating the limitations of statistical models and interpreting the outcomes within the broader economic context.

Assessments and Grading:

There will be **two** midterm exams each worth **20%** of the final grade, for a total of **40%**. The first midterm will be on **October 07, 2024**, and the second midterm will be on **November 18, 2024**. The final exam, worth **50%** of the final grade, will be cumulative and scheduled by the registrar. Only non-programmable, non-graphing calculators will be allowed during exams, and the use of cell phones will be considered as cheating. Also, there are **10** assignments, and to encourage collaborative learning, you are allowed to work on these assignments in a group. However, individual submission is mandatory for every student. These assignments are worth **10%** of your mark. No assignments are going to be accepted after the due date.

I will provide a PDF file that introduces the application of R programming for introductory econometrics. Although it is not mandatory to use R for this course, as all materials can be

completed using Excel, I highly recommend that you explore R. By doing so, you will gain a valuable head start for Econometrics II next semester and more advanced econometrics courses. Learning R now will equip you with the skills necessary for more complex analyses in the future and enhance your ability to work with larger datasets and more intricate econometric models.

Policies regarding missed assessments:

- Midterm exams: Following Western's new academic accommodation policy, students can only self-attest for one assessment. However, as the **second midterm** is central to the learning objectives for this course, students seeking academic consideration for this assessment will be required to provide formal supporting documentation. **There will be no makeup exams for midterms. Any student that either self-attests for midterm 1 or has valid accommodation for midterm 2 will have the weight of the midterm shifted to the final exam.** The instructor reserves the right to provide students in each case with a longer version of the final exam to measure the student's knowledge of the topics in the midterm that was not taken.

If approved, a makeup exam will be scheduled by the Department of Economics and will take place AFTER the original Final exam date.

- 1- Econometrics heavily relies on statistical techniques, so focus on statistical concepts, including probability, hypothesis testing, regression analysis, and time-series analysis.
- 2- Attend the office hours and ask questions.
- 3- Collaborating with peers in a study group can be beneficial. Discussing concepts with others can offer new perspectives and insights. Explaining concepts to your peers is also an effective way to reinforce your own understanding.
- 4- Practice, practice, practice.

Policies Regarding Academic Accommodation

- Academic accommodation will not be granted automatically on request. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with test or final exams.
- Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within **48 hours** when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor.
