Course Description:

In this course, we will develop the standard neoclassical growth model and then use it as a tool for economic analysis. We will compare the implications of this model to data. We will discuss the successes and limitations of this model in explaining cross-country income differences. We will extend the model to incorporate business cycle fluctuations to see how well the model can account for short-run movements of the economy.

Course Learning Outcomes:

- 1. Students will be able to set up the firm's and the household's problem within the standard neoclassical growth model, derive and interpret the corresponding equilibrium conditions.
- 2. Students will define and characterize a competitive equilibrium and link the resulting allocation with that of the benevolent social planner using the welfare theorems.
- 3. Students will understand what it means to calibrate the neoclassical growth model.
- 4. Students will be able to perform comparative statics exercises on the balanced growth path allocation in the neoclassical growth model and understand the transitional dynamics of the economy in the model, as it converges to a balanced growth path.
- 5. Students will be able to use the neoclassical growth model for growth accounting and will be able to evaluate the model based on balanced growth path predictions.
- 6. Students will be able to extend the neoclassical growth model to analyze short-run movements of the economy.

Textbook and Course Materials:

There is no required textbook for this course. Some notes or other course material <u>may be</u> posted on OWL Brightspace. You are responsible for all content covered during in-person lectures and any material posted on OWL Brightspace.

Assessments and Grading:

Your final grade is based on homework assignments (25%), a midterm (35%) and a final (40%).

Homework: There will be 3 homework assignments. Homework assignments are *due in-person*, *at the start of class* on September 25, October 9 and November 25. Late homework assignments will not be accepted. There are no make-up homework assignments. The homework assignments have *flexible grading*, meaning that the lowest assignment score is dropped from the calculation of your grade. This means that two (highest) homework assignments will <u>each</u> have a weight of 12.5%, and total 25% of your final grade. Given flexible grading, self-attestation is not accepted as consideration for missing to turn in homework. If you miss turning in any assignment (without approved accommodation) the grade is zero. If more than one homework assignment is missed with approved accommodation from Academic Counselling office, the weight of those assignments is split equally between the midterm exam and the final exam.

Midterm: The midterm is a 1.5-hour exam held during the usual class time on **Monday**, **October 28**. There will be no make-up midterm exam. You will be notified what material to focus on for midterm preparation.

Self-attestation <u>cannot be used</u> for consideration if students miss the midterm. If a student misses the midterm due to illness or other acceptable excuse the student must present official documentation justifying the absence to the Academic Counselling (AC) office. Email your

professor within 48 hours of the midterm time to notify that you are in the process of obtaining accommodation from the Academic Counselling office. For more details regarding academic accommodation, please see Western University's policies on pages 5 and 6 of this course outline.

If the academic counsellor *does not approve your absence from the midterm exam*, or if there is no justification for your absence, a grade of zero is assigned. If the academic counsellor *approves your absence from the midterm exam*, the weight of the midterm will be added to the final exam. In this case, you will also write a different final exam from the rest of the class, as it is necessary to test you on the entire course material.

Final: The final exam date is TBD by the Registrar's office. The final is a 1.5-hour exam for any student who took the midterm. This 1.5-hour final exam will be cumulative with an emphasis on more recent material. Students who received academic accommodation through the AC office and shifted the weight of the midterm to the final, will write a comprehensive 3-hour final exam. This 3-hour final exam will <u>test all the material</u> taught in this course.

Please note that in accordance with university policy, self-attestation cannot be used for final exams. If a student misses the final, they need to document and have their absence approved by the Academic Counselling office. Otherwise, a grade of zero is assigned to the final exam.

Tentative Outline of Topics

Introduction to the class and macroeconomics data One-period workhorse macroeconomics model: households, firms, equilibrium. Two-period and multi-period extensions of the model. Social Planner's Problem and Welfare Theorems. Neoclassical Growth model: long-run analysis, applications. Real Business Cycle model: short-run analysis, applications.
