Course Objectives:

This course is a continuation of macroeconomics 2152. In this course we will examine models of the business cycle, trade and international open economy issues, monetary and fiscal policy, employment and endogenous growth. Some policy issues will be also addressed.

Course Learning Outcomes:

Upon successful completion of the course, the student will be able to:

- use mathematical models to understand macroeconomic issues.
- use basic macroeconomic theories to analyze the facts observed in the data.
- explain the main macroeconomic theories of short-term fluctuations and long-term growth in the economy.
- explain how fiscal and monetary policy can affect the macroeconomy under different economic conditions within a business cycle.

The midterms and final exam will be mixed format (a combination of multiple choice, true/false, and/or fill-in-the-blank questions). Each midterm will be available to students for **2 hours** on the date of the assessment. Once you begin the midterm you will have **75 mins** until the **closing time** whichever is shorter to complete the midterm. Students will only be allowed to submit midterm once.

Policy Regarding Missed Assessments:

<u>There will be no make-ups for missed midterms.</u> Students who miss a midterm due to medical or compassionate grounds (and can provide the appropriate documentation) will have the weight transferred to the final exam. For all missed midterms, you must submit your valid documentation to Academic Counselling within 2 business days of the exam date. You must also notify your instructor prior to the test or at least within 24 hours after the excused period.

Students who miss the final exam, with approved documentation will write a makeup final exam that may differ in format from the original scheduled final exam and may be delivered on a different platform.

- 4. Inflation: Phillips Curves and Neo-Fisherism (Chapter 14)
- 5. International Trade in Goods and Assets (Chapter 15)
- 6. Money in the Open Economy (Chapter 16)
- 7. Search and Unemployment (Chapter 06)
- 8. Income Disparity among Countries and Endogenous Growth (Chapter 08)

Note: Not all chapters will be covered entirely, and some topics that are not in the textbook will be added to the lectures.

Policies Regarding Academic Accommodation

- Accommodation for Students with Disabilities: Students with disabilities or accessibility challenges should work with Accessible Education (formerly SSD, see http://academicsupport.uwo.ca/accessible_education/index.html), which provides recommendations for accommodation based on medical documentation or psychological and cognitive testing. - **Rewriting Exams and Retroactive Reweighting are NOT Permitted:** Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or retroactive reweighting of marks, is **not** permitted. Self-Reported Absences cannot be used once a student has proceeded to start to write a test or exam.
- Self-Reported Absences: Students will have two opportunities during the fall and winter terms to receive academic consideration if they self-report a missed assessment using the online self-reported absence portal, provided the following conditions are met: the assessment is missed due to an absence of no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted otherwise on the syllabus. Students are not able to use the self-reporting option in the following circumstances:
 - for exams scheduled by the Office of the Registrar (e.g., final exams)
 - absence of a duration greater than 48 hours
 - assessments worth more than 30% of the student's final grade
 - if the student has opened or started the test or exam
 - if a student has already used the self-reporting portal twice during the fall/winter terms

If the conditions for a Self-Reported Absence are *not* met, students will need to provide a Student Medical Certificate (SMC) if the absence is medical or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office for more information about the relevant documentation. It is strongly recommended that students notify the instructor as soon as possible, ideally before the assessment, when they become aware of an absence. University policy is that students must communicate with their instructors no later than 24 hours after the end of the period covered by the SMC or immediately upon their return from their documented absence. Failure to follow University policy and procedures may result in denial of academic accommodation and a grade of zero.

- Documentation for Accommodation: Individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds or for other reasons. All required documentation for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.
