# **Course Objectives:**

This course is a continuation of macroeconomics 2152. In this course we will examine models of the business cycle, trade and international open economy issues, monetary and fiscal policy, employment, and economic growth. Some policy issues will be also addressed.

# **Course Learning Outcomes:**

Upon successful completion of the course, the student will be able to:

- use mathematical models to understand macroeconomic issues.
- use basic macroeconomic theories to analyze the facts observed in the data.
- explain the main macroeconomic theories of short-term fluctuations and long-term growth in the economy.
- explain how fiscal and monetary policy can affect the macroeconomy under different economic conditions within a business cycle.

# **Policy Regarding Missed Assessments:**

<u>There will be no make-ups for missed midterms.</u> Students who miss a midterm due to medical or compassionate grounds (and can provide the appropriate documentation) will have the weight transferred to the final exam. For all missed exams, you must submit your valid documentation to Academic Counselling within 2 business days of the exam date. You must also notify your instructor prior to the test or at least within 24 hours after the excused period.

Students who miss the final exam, with approved documentation will write a makeup final exam that may differ in format from the original scheduled final exam and may be delivered on a different platform.

- 6. Money in the Open Economy (Chapter 16)
- 7. Search and Unemployment (Chapter 06)
- 8. Economic Growth: The Solow Model (Chapter 07)
- 9. Income Disparity among Countries and Endogenous Growth (Chapter 08)

Note: Not all chapters will be covered entirely, and some topics that are not in the textbook will be added to the lectures.

# **Policies Regarding Academic Accommodation**

- Academic accommodation will not be granted automatically on request. Students must demonstrate by documentation that there are compelling medical or compassionate grounds before academic accommodation will be considered. Rewriting tests or examinations, or retroactive reweighting of marks, is **not** permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with tests or final exams.
- Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within 24 hours when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. If the instructor is not available, send an email message to the instructor, copying the Undergraduate Coordinator at <a href="mailto:econugrd@uwo.ca">econugrd@uwo.ca</a>. Notifying instructors of a missed exam does not automatically entitle students to a makeup.
