#### **Course Objectives:**

The goal of this course is to provide you with the economic and legal aspects of labour relations. You will learn about the history and origin of the trade union movement, the

economics of trade unions, labour law, the wage/non-wage effects of trade unions, and the relationship between unions, firms, and governments.

#### **Course Learning Outcomes:**

Upon successful completion of the course, the student will be able to:

- Recognize and understand the rationales and effects of union interventions in the labour market as well as various government and legislative influences
- Apply the assumptions and predictions of the basic labour market and union models to make outcome predictions and explain related policy implications in terms of economic theory
- Interpret issues arising in labour relations to evaluate outcomes in hypothetical, historical, and/or contemporary situations

- Exam duration: The duration of each midterm exam is 75 minutes. The duration of the final exam is 120 minutes.

#### Policies regarding missed assessments:

Midterm Exams: There will be no make-up exams for missed midterm exams. If you know in advance that you cannot attend a midterm exam, you must take your documentation to Academic Counselling before that exam. If you miss a midterm exam, you must notify your instructor within 24 hours of the missed exam and take your documentation to Academic Counselling within 48 hours of the exam. If Academic Counselling accepts your documentation, the percentage of the missed assessment will be allocated to the final exam.

- Rewriting Exams and Retroactive Reweighting are NOT Permitted: Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or retroactive reweighting of marks, is **not** permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with tests or final exams.
- Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within **24 hours** when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor.
