# **Course Description**

This course will cover the expenditure side of public finance. The course will focus on welfare economics, market failures, cost benefit analysis, public choice and the role of government. Specific expenditure programs, in a Canadian context, will also be examined.

# **Course Objectives**

Students will examine the rationale for public provision of goods or services.

Students will learn to evaluate the efficiency of program spending.

Students will be prepared to engage in debates on the public vs. private provision of services such as health care, pensions etc..

# **Required Course Materials**

Textbook: Dahlby, Smith, Boothe: Public Finance in Canada, 5th Canadian edition (McGraw-Hill).

Students are reminded not all of the course subject matter is covered in the text. Class notes and discussion make up an <u>integral</u> part of the <u>required</u> course material.

#### Assessments & Grades

There will be two midterm tests and a final exam.

# **Policies Regarding Academic Accommodation**

- Academic accommodation will not be granted automatically on request. Students
  must demonstrate by documentation that there are compelling medical or
  compassionate grounds before academic accommodation will be considered. The

- Rewriting Exams and Retroactive Reweighting are NOT Permitted: Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or retroactive reweighting of marks, is not permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with tests or final exams.
- Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within 24 hours when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. If the instructor is not available, send an

email message to the instructor, copying the Undergraduate Coordinator at <a href="mailto:econugrd@uwo.ca">econugrd@uwo.ca</a>. Notifying instructors of a missed exam does not automatically entitle students to a makeup.
