Course Description:

This course introduces the linear regression model as a means to estimate and assess economic relationships. We study the interpretation of the ordinary least squares estimator as well as its asymptotic distribution. We will pay particular attention to linking the underlying economic model and the data. Building on concepts in EC2222, we show how to construct confidence

intervals and conduct hypothesis tests for parameters in the linear regression model. We cover basic time series and panel data analysis.

- Use regression models to analyze economic relationships
- Understand the meaning of regression coefficients
- Conduct hypothesis tests and construct confidence sets for the linear regression model

Textbook(s) and Course Materials:

Wooldridge, Jeffrey, Introductory Econometrics: A Modern Approach, 7th edition, South-Western.

Note: The 5th or 6th editions of the textbook may be cheaper and are very similar to the 7th edition. The main difference will be that the homework and readings I will assign will be numbered using the 7th edition.

- **Rewriting Exams and Retroactive Reweighting are NOT Permitted:** Students who proceed to write a test or examination must be prepared to accept the mark.
