Course Description:

This course is about the performance, advantages, and pitfalls of different institutions used to allocate resources, focusing on markets. We will combine tools you learned in EC2260 with new tools from Social Choice, Game Theory, and Mechanism Design. We will begin discussing ways to evaluate social outcomes from a social perspective, balancing out the preferences of different members of society. Later on, we will analyze a stylized model of perfectly competitive markets that can achieve desirable outcomes under ideal circumstances. Then, we will identify several issues that may lead to market failure, including market power, public goods, externalities, and information frictions. We will conclude by analyzing some alternative mechanisms to deal with such issues.

Course Learning Outcomes:

As a result of taking this course, the students will understand the basic microeconomic concepts and tools that are required for more advanced specialized economic courses. They will also be able to apply these concepts and tools to analyze real life economic situations. Specifically, the students will learn the most essential microeconomic concepts including Pareto efficiency, social welfare, demand and supply, competitive equilibrium, dominant strategies, Nash equilibrium, market power, collusion, price discrimination, public goods, externalities, and asymmetric information. The students will understand the determinants of demand and supply and market outcomes, including various public policies. The students will learn to identify the circumstances when the market performance is likely to be suboptimal, and which market interventions and/or alternative allocation mechanisms could help.

Assessments and Grading:

Your final grade will be determined as follows:

- 30% from the first midterm exam to be held tentatively on February 5
- 30% from the second midterm exam to be held tentatively on March 15
- 30% from the *cumulative* final exam to be held during the finals period
- 10% from three problem sets and in-class participation

Midterm exams.– The midterm exams will be held in person from 2:30 until 4:30 in a location to be determined. There will be no make-up midterm exams. If you miss one midterm exam, I will simply transfer the weight to remaining two exams. Please try to not miss both midterms.

Problem sets.– There will be one problem set for each exam. They are meant to help you prepare for the exam. There will be a discussion forum for each problem set, and you are encouraged to ask questions and help each other out. However, you must submit your solutions individually.

MobLab.– We will employ <u>MobLab</u> for in-class activities. These activities are meant to help get a better grasp of some of the concepts taught in class. Your participation and performance in these activities will count towards your final grade as a fourth problem set. In order to participate in these activities, you will need an internet-enabled device such as a smart phone. You will also have to purchase an individual license.

Policies Regarding Academic Accommodation

- **Rewriting Exams and Retroactive Reweighting are NOT Permitted:** Students who proceed to write a test or examination must be prepared to accept the mark. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with tests or final exams.
- Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within **24 hours** when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. Notifying instructors of a missed exam does not automatically entitle students to a makeup.
