Course Objectives:

This course is an introduction to machine learning for big data sets for use in economic analysis. Machine Learning employs techniques for analyzing large data sets and emphasizes making predictions rather than describing the data. The econometric methods covered in Economics 2222A/B and Economics 2223A/B are extended to common machine learning methods such as random forest and artificial neural networks. The software of instruction is publicly available, and methods will be presented using R (R Studio).

Course Learning Outcomes:

This course is intended to introduce students to the main areas in machine learning and want to apply this understanding to big data.

- Students will learn about how data analysis methods change depending on the desired outcome of the analysis. Students will learn about the distinction between descriptive models (i.e., ordinary least squares) and predictive models, and which is more relevant for your data.
- Students will be introduced to the theory behind several machine learning methods, including:
 - Ridge regression
 - Lasso regression
 - Elastic Net regressions
 - Principal Component Analysis
 - Logistic Regression
 - Decision Trees
 - Random Forests
 - o Artificial Neural Networks
- Students will apply these methods to big data (many observations) using R (R Studio) and provide their interpretation of the results.
- By the end of the course, students will have demonstrated a solid understanding and competency in R (R Studio), in areas of data management, analysis, and presenting data.

R for Economics:

On OWL you must join the "R for Economics" site. This site is a <u>self-study online program</u> that allows students to learn R from highly specific short videos (2-5 minutes each). The lessons cover all the major aspects that are used in economics, and relevant methods used for this course.

The major topics are:

- Getting started (installing R Studio)
- Basics
- Data manipulation

- Programming
- Plotting and Graphs
- Regressions
- Advanced Estimation
- Machine Learning

The self-study is ordered and should be followed from first to last. (Note the videos were recorded in a slightly different order so some references to other videos may be out of sequence.)

R for Economics Quiz Points:

- Progression through the "R for Economics" self-study is tracked by short quizzes that assess your knowledge of commands and your ability to find solutions.
- A student's accumulated points (up to 100 points) will determine their grade.

Labs:

- Each lab will have a short task that can easily be completed during the lab. The labs are designed to assist students to develop the skills required to complete assignments.
- Lab results will be submitted to OWL.
- Students will have up to one calendar week to submit the lab results.

Assignments:

- Data for assignments will either be provided or publicly available for download.
- Data will need to be cleaned before analysis.
- Analysis will use the methods outlined above.
- Deliverables will include: a written summary of results, and the R code used.
