# **Course Objectives:**

This course aims to introduce you to the macroeconomics principles that will enable you to understand and interpret economic events around you. You will learn what causes the economy to go through cycles of growth and contraction and how the government can influence the economy to attempt to moderate these cycles.

# **Course Learning Outcomes:**

Upon successful completion of the course, the student will be able to understand, explain and analyze:

- The various measures of macroeconomic activity
- The economic models that determine equilibrium in an economy
- How market participants interact with each other and the impact of these interactions on a national and global level
- The various phases of the business cycle and explain how key macroeconomic variables behave in these phases
- The requirements for long-term growth
- Monetary and fiscal policy, including (i) their effects on the economy, (ii) the advantages and disadvantages of various types of policies, and (iii) the role of the Bank of Canada and the government in implementing these policies.

- Please note that all times and dates mentioned above are tentative and subject to Exam Central's approval. The assessment dates, times, and choices may change if classes move to an online status. All times are ET.
- Exam format:
  - o Midterms and the final exam are MCQs, in-person, closed-book exams.
  - Quizzes will require answering short-answer questions, including showing calculations and drawing graphs.
- Exam duration: Each midterm exam lasts 90 minutes, the final exam 120 minutes, and each quiz 15 minutes.
- During exams, students are forbidden to communicate with anyone other than an examination proctor or the instructor. Students are NOT allowed to use any books, notes, study guides, diagrams, communication equipment such as a cell phone, computer programs or software, online resources or websites, or other aids unless authorized by the instructor; such authorization must be stated explicitly during the examination.
- Students should notify the instructor of conflicts with these test dates before January 28, 2025.

#### • Policies regarding missed exams:

Midterm Exams: There will be no make-up exams for missed midterm exams. Students can miss one midterm exam using self-attestation and notification to the instructor before or within 24 hours of the missed exam. If a student misses both midterm exams, they must obtain approval from Academic Counselling for the other missed exam and must notify the instructor before or within 24 hours of the missed exam. If a student misses both midterms without using self-attestation and without approval from Academic Counseling, they will receive a grade of zero for both exams. The weight of any approved missed midterm exam or exam using self-attestation will be transferred to the final exam.

#### Ouizzes:

- There will be no make-up exams for missed quizzes. As the quizzes have a flexible grading policy, self-attestation will not be accepted.
- The best two out of three quizzes will count towards the final grade, with each quiz contributing 5 points. Students do not need to notify the professor if they miss one quiz, and no academic consideration or medical

- documentation is required for missing one quiz.
- If a student attends all quizzes, the best two scores will be used for grading.
- If a student misses two quizzes, they must receive approval from Academic Counseling for one of the quizzes. Without approval, the student will receive a grade of zero. With approval from Academic Counseling, 5% of the second missed quiz will be transferred to the final exam.
- If a student misses all quizzes, with approval from Academic Counseling, the entire 10% weight allocated for quizzes will be transferred to the final exam.
- o **Final Exam:** The final exam will cover materials from the entire term. Students who miss the final exam must take their documentation to Academic Counselling and notify the instructor within 24 hours. Once Academic Counselling approves your documentation for the missed Final exam, the instructor will set a makeup date. Students who miss any assessment must follow Western University's procedures to approve their absence to receive accommodation. If a student does not receive approval from the Academic Counselling for the Final exam, the instructor will assign a grade of zero for that exam.
- Notes: It is strongly recommended that students attend all exams. Doing so helps you better understand the concepts, stay regular, and perform well. The final exam is cumulative and, therefore, more challenging than the midterms and quizzes.

#### **Policy Regarding Makeup Tests and Final Examinations**

Faculty of Social Science policy states that oversleeping or misreading an exam schedule is NOT grounds for a makeup. This rule applies to midterm and final exams in the Department of Economics.

#### **Policies Regarding Academic Accommodation**

- Academic accommodation will not be granted automatically on request. Students must demonstrate by documentation that there are compelling medical or compassionate grounds before academic accommodation will be considered. - Rewriting Exams and Retroactive Reweighting are NOT Permitted: Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or retroactive reweighting of marks, is **not** permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with test or final exams.
- Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within 48 hours when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. If the instructor is not available, send an email message to the instructor, copying the Undergraduate Coordinator at <a href="mailto:econugrd@uwo.ca">econugrd@uwo.ca</a>. Notifying instructors of a missed exam does not automatically entitle students to a makeup.
