You are responsible for ensuring that you have successfully completed all course prerequisites, and that you have not taken any anti-requisite courses. Lack of prerequisites may not be used as a basis for appeal. If you are found to be ineligible for a course, you may be removed from it at any time and you will receive no adjustment to your fees. This decision cannot be appealed.

If you find that you do not have the course prerequisites, it is in your best interest to drop the course well before the end of the add/drop period. Your prompt attention to this matter will not only help protect your academic record, but will ensure that spaces become available for students who require the course in question for graduation.

Course Description:

We will study theoretical models that help understand the determinants of exchange rates, current account imbalances, and international mobility of capital flows. We will review and evaluate

changes in global capital market integration over time. These models will be used to discuss global determinants of global interest rates, policy issues such as trade and debt policies, and how monetary policy decisions and structural reforms impact on the exchange rate.

Course Objectives:

The course offers a foundation to interpret salient features of global capital markets. The integration between theoretical models and data guides students through the process of how economics can be used to understand the real world.

Course Learning Outcomes:

By the end of this course, students will learn to understand the aggregate determinants of the trade balance, international capital flows, and key global asset prices such as the exchange rate and interest rate. This will require

- Use models of foreign exchange determination to explain currency fluctuations in the short and long run.
- Solving 2-period intertemporal models of current account determination in open economies and studying the effects of various shocks and government policies.
- Use models to guide the interpretation of data. The models studied in class will be used to identify the sources of aggregate fluctuations in open economies.
- Identify unsustainable external debt dynamics.

Textbook and Course Materials:

The required textbook for this course is Schmitt-Grohe, Uribe, and Woodford, "International Macroeconomics," which is available in the bookstore. The textbook price is \$106.75. The textbook will be complemented with lecture notes.

Students are welcome to purchase second-hand or earlier editions of this textbook.

Assessments and Grading:

The course will have four homework assignments, class quizzes, a midterm and a final exam. Homework assignments will be posted online and each one will be due one week after it is posted. Your assignment must be uploaded to owl before the deadline. You may discuss the problems and solutions with your classmates, but you must each write up your own individual assignments independently. Identical or essentially identical assignments will receive a grade of zero.

There will be weekly quizzes. Some will be assigned online, and some may be assigned in class. Quizzes will provide a first application of the material covered in the course or be used to motivate the introduction of concepts. They will only be solved in class, and no solution will be

posted. The quiz scores and your class participation will determine your class participation grade. The two quizzes with the lowest grades will be removed when computing the final quiz score. There will be no credit for quizzes submitted after their deadline.

The midterm exam will be held during class time. **Self-attestation is not allowed for the midterm**. The midterm and final are not cumulative. The material for the exams consists of the topics covered in class, any assigned readings, and the material covered in the homework assignments. The exams will consist of 10-15 short questions. The format will range from multiple-choice, filling-the-blank, drawing and interpreting diagrams, to writing a short paragraph. The questions will test the understanding of concepts and economic models, how the studied models can be used to interpret news, public discussions, and data. The duration of the midterm and final will be 90 minutes.

There will be no other source of credits in the course.

The distribution of the marks is as follows:

Midterm 30% Homework assignments 20% Class participation 20% Final 30%

The midterm and final exams will be conducted through the owl website. You must bring your laptop to the assigned classroom to take the exams.

Exams are open book. Students can consult the textbook, lecture notes, slides, and answer keys for homework and quizzes. However, students are forbidden from communicating with anyone other than an examination proctor or consulting any web page during exams. Students will need to use a calculator to assist them with numerical calculations.

Policies regarding late homework submissions.

- Late homework submissions without documentation and timely notification to the instructor will be subject to a late penalty of 20%/day.
- Late assessments with illness self-reports must be submitted within 24 hours of submission of the last illness self-report.
